## **The John Chadwick Pet Policy**

I am truly humbled to be here today, to present The John Chadwick **Pet Policy – In Loving Memory** 

Affectionally known as my Hun, this is John, Theo, Tinkerbell & their feline best friend Gizmo. John was a gentle and kind man.

The bond he had with his Pets, I am unable to describe by words alone. No-one can take these memories from me.....











## **The Early Years**

John was born in Salford, and due to unforeseen events, had become Street Homeless in London for 2 years. He was found wandering, by St Mungos Homeless Charity and later transferred to Kenward Trusts Drug and Alcohol Rehabilitation, in Yalding, Kent in 2007. He completed a 6 month Alcohol Treatment Programme and later secured a tenancy with a Private Landlord, in Maidstone, Kent.

I met John at the latter end of 2007. I was so inspired by his journey, I later became employed with Kenward Trust on 2<sup>nd</sup> December 2010. I am still employed with them today.

I acquired Gizmo as a kitten for John, to assist with his recovery and mental well being. He then later acquired Theo and then Tinkerbell. His family was complete. They were his babies, his lifelines, his everything.

John had a life with us here in Maidstone, he worked, had friends, and was part of "my family". He adored my grandchildren, and would spend Christmas with us, so he wasn't alone.

## **Section 21 in 2016**

John was served with a Section 21 at the latter end of 2016, the private landlord

wanted to sell the property. He was evicted on 6<sup>th</sup> March 2017, separated from his

Pets, and placed in a B&B by Maidstone Borough Council. He was later given one

offer only of permanent housing, with a No Pet Policy.

If John had declined the offer, he would become intentionally homeless. Most

cannot imagine becoming homeless once in their lifetime, this was John homeless

for the 2<sup>nd</sup> time, during his.

John died by Suicide on 16<sup>th</sup> March 2017, 10 days after being separated from his

Pets. This was also the Anniversary of his Mothers passing.

## **New Pet Policy 2018**

# GHANGED

I channelled my grief into a Platform Of Change, to ensure this tragedy didn't happen again. The support given by the media and charities, both here in the UK and abroad, was truly overwhelming.

In July 2018, a New Pet Policy for Emergency Accommodation, was implemented by Maidstone Borough Council. Those now facing homelessness, being able to take their pets with them, if the properties were suitable to do so.







## **New Pet Policy Review 2019**

In November 2019, I requested Maidstone Borough Council and The Communities, Housing and Environment Committee to review the clause in the New Pet Policy. I had become a lot stronger and wiser by then.

I also contacted Councillor Malcolm Mckay, who was honest to say he was not a pet lover. However, he listened and agreed further change was needed within the Policy.

We began a journey of our own together, were filmed on BBC South East News (my 2<sup>nd</sup> time!). We attended numerous panel meetings at the Town Hall.

The clause within the Policy had stated, MBC would not deem it an unreasonable offer, should permanent housing be offered with a No Pet Policy. I had viewed this as assisting those already at their most vulnerable with their pets, being helped half-way up the ladder into emergency accommodation, and then either becoming intentionally homeless, should they refuse the permanent offer, or face the dilemma of giving up their Pets.

## Pet Pilot Scheme 2020



The Communities, Housing and Environment Committee Panel took my request on board.

At the Town Hall on 25<sup>th</sup> August 2020, the Panel voted for a 1 year Pilot Scheme to be implemented.

This would allow those residing in emergency accommodation with their pets, to be able to decline the 1<sup>st</sup> offer of permanent accommodation, on the grounds the accommodation being unsuitable for the pet or came with a No Pet Policy.

I understood the concerns raised by the Panel, as to whether this may affect the waiting list for emergency accommodation.

A further review would be conducted at the end of the 1 year period, where we would go back to Panel once more.









#### **The John Chadwick Pet Policy**

Maidstone Borough Council's approach to accommodating homeless applicants and their pets.

1. Introduction

- 1.1. Maidstone Borough Council recognises that our homeless applicants may need to keep pets whilst being housed in accommodation under the Homelessness statute. Where possible Maidstone Council will endeavour to accommodate the household where it is suitable and permitted for pets.
- 1.2. At all times we will endeavour to keep households and their pets together, as we understand that they play an important and supportive role, to households facing this stressful situation.
- 1.3. However, it is noted that the current legal position regarding the homelessness legislation does not consider pets to be part of the household. This could mean that in an emergency, if no properties are available where a pet is allowed to reside, then the pet may not be taken into consideration when making a suitable offer of temporary accommodation. By way of explanation the Homelessness Code of Guidance states:

"Housing authorities will need to be sensitive to importance of pets to some applicant, particularly elderly people, rough sleepers who may rely on pets for companionship. Although it will not always be possible to make provisions for pets, the secretary of state recommends that housing authorities give careful consideration to this aspect when making provision for applicants who wish to retain their pet"

- 1.4. Under this policy we will seek to keep pet(s) with the applicant in their temporary accommodation and when making an offer of accommodation to end the homelessness duty. In making the final offer, officers will take into consideration whether the landlord permits pets at the property and exercise their judgement as to whether the offer would be suitable. The Council acknowledges that housing providers (including private landlords) are likely to have their own policy as to whether pets are permitted in their accommodation and the Council does not have the authority to overrule their decision.
- 1.5. In normal circumstances if the applicant were offered accommodation where pets are not permitted, the offer of accommodation would not normally be considered as unsuitable on the basis that the pet not being able to join the applicant. Whilst the approach outlined in this policy is not an overriding consideration when examining the suitability of an offer, the officer may accept up to one refusal of a suitable offer under the John Chadwick Pet Policy without penalising the applicant.

### The John Chadwick Pet Policy 2021

On 6<sup>th</sup> April 2021, I attended a further Panel meeting with Councillor Malcom McKay, to request the Pilot Scheme to be implemented as a Pet Policy.

I also made a further request, as to naming the Pilot Scheme and the Pet Policy for Emergency Accommodation after John Chadwick.

On 6<sup>th</sup> October 2021, I attended the Town Hall once more. On this evening, Councillor McKay was sitting on the actual Panel.

The Panel voted unanimously for the Pet Pilot Scheme to become a permanent Policy and for this and the Policy for Emergency Accommodation, to be named The John Chadwick Pet Policy.

Maidstone Borough Council confirmed, there had been no issues as feared previously. The waiting list for Emergency Accommodation, had not been affected in the numbers they had thought, by pet owners waiting for suitable permanent accommodation.

## **Kenward Trust Street Reach 2022**

This gives us as the Street Reach Team, an opportunity to provide clothes, food and a pop in, without being intrusive. So I now have that "little something for me" too.

And Little Rocky in the photo with me, is now living his best life with his human!!
